This is a Contract between Lucky Dog Lodge and the pet owner whose signature appears below (hereinafter called "Owner").

1. Owner agrees to pay the rates for boarding in effect on the date pet is checked into the Lucky Dog Lodge (as posted in office.)
2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of the Lucky Dog Lodge.
3. Owner further agrees that the pet shall not leave the Lucky Dog Lodge until all charges are paid to Lucky Dog Lodge by Owner.
4. By signing this Contract and leaving his pet with Lucky Dog Lodge, Owner certifies to the accuracy of all information given about said pet.
5. Lucky Dog Lodge shall exercise reasonable care for the pet delivered by the Owner to Lucky Dog Lodge for boarding. It is expressly agreed by Owner and Lucky Dog Lodge that Lucky Dog Lodge's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per animal boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Lucky Dog Lodge.
6. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
7. Owner specifically represents to Lucky Dog Lodge that the pet has not been exposed to rabies or distemper within a thirty day period prior to boarding.
8. All charges incurred by Owner shall be payable upon pick-up of pet or when billed by Lucky Dog Lodge at address listed on contract. The Lucky Dog Lodge shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding a pet at the Lucky Dog Lodge. The owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the Lucky Dog Lodge may exercise its lien rights upon ten days written notice given by Lucky Dog Lodge to Owner by certified mail to address shown on contract. Lucky Dog Lodge may dispose of pet for any and all unpaid charges, at private or public sale, in the sole discretion of the Lucky Dog Lodge, and owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure caprice adequate to pay such cost of board or other charges delinquent, plus costs of sale, then Owner shall be liable to Lucky Dog Lodge for the difference. All monies realized by Lucky Dog Lodge at such sale, over and above the charges due and costs of sale, shall be paid by Lucky Dog Lodge to Owner.
9. If pet becomes ill or if the state of the animal's health otherwise requires professional attention, the Lucky Dog Lodge, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner.
10. This contract contains the entire agreement between parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Lucky Dog Lodge.
11. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as a result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and the judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
